A message from the Chair of Trustees

Despite the strange times in which I write this introduction, I am delighted to say that we have managed to continue to grow and prosper over the last year. As the impact of the global pandemic will not be apparent until the next financial year as it only appeared in the closing weeks of 2019-20, we continue to be able to inform you, our carers, with good news about the levels of support we have provided over the year.

Hillingdon Carers, and our partners in the Hillingdon Carers Partnership, have supported more carers this year than ever before. We are exceeding our targets for the identification of 'hidden carers' – those carers that perhaps don't recognise the essential role they play in caring for a loved one.

The Young Carers team is supporting an estimated 50% of the young people in the borough that have a caring role, and, for adults, we are supporting over 30%. This is great news, but there remains a lot to do. In 2020-21, we will double our efforts to find carers that might benefit from our services, as well as continuing to grow the levels of support and range of services that you tell us would help.

I am hopeful that our AGM will go ahead in October and that I will meet some of you then. Please keep an eye on our website and in your late summer newsletter for details. Sending very best wishes to you all, keep doing what you do, you are amazing!

Report from the Treasurer

The Board of Trustees and the Finance Committee have continued to exercise close and careful control of the organisation's finances over the past 12 months. We remain in a strong place financially in these challenging times, not least because of the generosity of the London Borough of Hillingdon and the value it places on the borough's rich and diverse voluntary sector.

Our financial success is also due to the staff team, which has an excellent track record of listening to you, our carers, understanding what you need, and then using this information to apply for new resources to develop new services. Grant-giving bodies, Foundations and Trusts value the evidence behind our applications, which has resulted in a strong success rate for our bids. They also value partnership working and many of our applications are submitted jointly with our partners. We will continue to listen and to work hard to secure the resources we need to maintain the growth we currently deliver year-on-year.

Our auditors, Cox Costello Horne have confirmed a small surplus of around £8,000 this year and we have healthy reserves in the bank in preparation for the year ahead, which we anticipate will get tougher due to the global situation.

I have enjoyed my first full year as Treasurer at Hillingdon Carers and look forward to the challenges ahead.

However, the Annual Report is about looking back, not looking forward, so I am pleased to be able to share some of our highlights with you from 2019 and early 2020 – an easier task than trying to predict what we will be doing in three months' time!

As our Chair, Dolores said in her introduction, we have had another positive year of growth and development. The Carers Partnership now offers well over 100 free services for you, Hillingdon's amazing carers, many funded through new grants. Our key achievements are listed in more detail on the next page.

I will sign off by saying on behalf of all the staff and trustees that we hope that you have weathered the lockdown without too much personal or familial disruption. If you haven't, please get in touch with the team, there are lots of ways we might be able to help you through any problems, or support you to come to terms with some of the potentially devastating results of the Covid-19 crisis.

Key achievements in 2019/20

- Since we started delivery of the Combined Carers Service contract in September 2016, Hillingdon Carers Partnership has successfully secured £1,231,341 of new investment for new services that benefit Hillingdon's carers
- We were successful in the partnership bid between Hillingdon Carers and Hillingdon Mind to the Big Lottery to improve support for carers of someone with a mental health condition. We were awarded £224,849 over three years to strengthen and develop our support and the programme will commence on 1 June 2020
- In 2019/20 we supported 7,851 (30.2%) adult carers and 1,237 (50.1%) young carers, significantly exceeding our contracted targets. In the year, we registered 796 new adult carers and 212 new young carers
- Our hard-working Advice team secured £864,242 in carer-related benefits against a backdrop of continued welfare reform, which saw a 39% increase in the numbers of appeals that the staff had to submit on behalf of carers
- We have introduced four new services in 2019/20:
 - IT surgeries for carers who need a little extra help to get online, Skype family members or manage food shopping or banking online. Our fabulous volunteer has also helped carers to access some of our new online services during the lockdown
 - A psychotherapeutic support group for carers of someone with an acute mental health condition
 - An art group for carers who attended our arts courses now meets regularly at the Carers Centre. Group members have displayed their work extensively and it will be displayed semi-permanently at the Beck Theatre later this year
 - A Young Adult Carers app has been developed to improve communication with teenage and young adult carers. Our young people worked with two final year students through a series of certificated design workshops to create the product, which will be piloted over the coming months
- We have provided adult carers with 2,790 breaks from caring through our Health and Wellbeing services, and young carers have accessed 3,519 breaks from their caring roles
- Our partners in the Hillingdon Carers Partnership have supported 602 carers
 with specialist provision dementia support, mental health support, carer
 short breaks (respite/replacement care in the home) and through our popular
 therapeutic care programme.



H4All activity in 2019/20

Hillingdon Carers continues to play a very active role in the development of H4All, along with its four other charity partners. The organisation has continued to grow and to thrive in 2019/20, here are just some highlights:

 H4All continues to support Hillingdon's community and voluntary sector to engage in new, collaborative ways of working to improve population health and wellbeing

"An outstanding organisation that is supporting numerous great causes in the borough. The work that they do to encourage and facilitate collaboration of local community groups, is going to have a huge impact on the Health and Wellbeing of Hillingdon residents."

- Support provided has included:
 - Establishing a Health and Wellbeing Alliance of 45 member groups and organisations
 - The development of a thriving Volunteer Hub, which has placed 36 new volunteers with 11 organisations
 - Delivery of a central training programme with 104 attendances across five workshop sessions
- An investment from National Health Service England (NHSE) into the development of the H4All model across North West London and inclusion in their national third sector Leadership programme.
- The award by Hillingdon Health and Care Partnership (HHCP) of three new contracts in order to extend their flagship Wellbeing Service to other targeted cohorts of the population.
- H4All stepped up to work in partnership with LBH to establish the Covid Response 'Hub'. At the height of activity they were delivering close to 40 emergency food parcels per day and collecting prescriptions for similar numbers of residents.

Young Carers Our 2019-20 highlights

We hope that regular readers of our Annual Report know that we are always looking for our next adventure. Here are just some of our exciting highlights from the year:

Snow way!

10 Young Carers were given the fantastic opportunity of undertaking a snow sports course at Hemel Hempstead Snow Centre. Along with two of our intrepid support workers, they spent two days learning how to snowboard before achieving their accredited 'Snowlife Award', with accompanying medals and certificates. One young adult carer enjoyed the course so much that she went on to take a further two courses funded by grants obtained by Hillingdon Carers and she has now qualified as a snow sports instructor.

National Steering Group

We now have three of our young adult carers sitting on the national Carers
Trust steering group. Not only does the steering group teach these young
people skills in leadership, teamwork and communication, it also gives them the
chance to influence services, shape national policy and improve opportunities
for young adult carers across the UK.

Family Support Service

Our two Family Support Officers have been hugely successful in making a positive difference to the lives of our most vulnerable families. They have supported 25 families throughout the year and have assisted with school attendance, debt management, housing issues and grants for essential items. In addition, they ran three whole-family trips to Go Ape, Brighton and London Zoo, where families were given the opportunity to socialise, have a break from home and to make happy memories together.

Art achievements

During the course of a weekend residential break, eight young carers created a range of amazing artworks based upon the theme of well-being. The work was collated into a joint piece entitled 'Mind Matters' and was then entered into a visual art competition run by London Youth and judged by the Youth Advisory Board. Whilst we narrowly missed out on the top prize, we were awarded an 'Honourable mention' by the judges and the artwork was published on Instagram.

Making young carers 'app-y'

Our young adult carers worked with two Brunel University students to research and co-design an app that will make communication easier and can be used to access information about our services and available activities. The design is now complete and will be piloted in the coming year with the aim of expanding the content for our younger age group.






Information and Advice team




Volunteers contribution from 2019 to 2020
