A message from our Chair of Trustees, Dolores Lee



What a difference a year can make! This time last year the Annual Report introductions from the Board and our Chief Executive were dominated by the pandemic and the impact of the lockdown on the lives of you, Hillingdon's unpaid carers. At least now, as an organisation, we are back to business as usual and all our services have been reinstated, with some new additions along the way.

However, we are under no illusions that the impact of the virus and subsequent lockdowns have gone away. We are still responding to the new needs that the global situation has created for carers and have had to think long and hard about the best use of our resources – plus bid for new funding – to meet those needs. It is testament to our skilled team at Carers Trust Hillingdon that they have taken every opportunity to listen to your experiences and respond accordingly. There are more details on page 5 about new services that have been developed according to your feedback.

We would like to reinforce that we are still listening and are happy for you to contact us at any time via email, telephone, our website or through your contact with staff, to share any major challenges or issues that you are experiencing; we can't promise to manage everything, but we will work hard to find a way to develop the support you need. Here's hoping that your lives have started to return to normal and that there is a growing bright light at the end of the tunnel. If not, please call us, we will try to help.

I am happy to report that Carers Trust Hillingdon continues to be in good financial shape and we finished 2021-22 with a small surplus of £21,000 and a confirmed income of just over £1.4 million. We also have a healthy surplus of reserves, currently above our standing reserves target.

This time last year, when the Board of Trustees was considering the end of year financial position, we took a prudent approach to the high levels of reserves that accumulated, in the main, during the first prolonged lockdown in 2020. The surplus was acquired through the combination of extra government Covid grant funding and the reduced cost of delivering services as many were moved online, therefore not needing investment in room hire, refreshments, volunteer expenses and staff travel. However, our world has stabilised somewhat, and, as Dolores mentioned, we have seen a lot of new and emerging needs as carers try to get some semblance of normality back into their lives.

We have therefore taken the decision to invest excess reserves into the development of new services. In short we have match-funded a grant for a new programme of work in schools to support young carers. Additionally, we have invested funding in supporting carers caring for someone at the end of life, including training, emotional support and ongoing support as caring finishes after the death of a loved one. Here's hoping your lives are getting back to normal, whatever the new 'normal' is.

It is clear that the pandemic has created personal and family issues for many of this extended team. It is testament to their professionalism and commitment that they were able to put the personal to one side in order to continue to work and deliver what they have: thinking creatively, responding rapidly and generally ensuring that Carers Trust Hillingdon is an organisation to be proud of. I sincerely hope that they are all now in a better place and are managing to come to terms with whatever things they have experienced, whether that is something visible, such as the loss of a loved one, or a very private and personal reaction to the world as it was.

I also extend those sincere wishes to you, our amazing carers. You have also been through probably the most challenging times of your caring journeys. We know first-hand that, over two years ago, the brief periods of respite that you previously enjoyed were snatched away virtually overnight as day centres, luncheon clubs and a whole myriad of support services had to close their doors. Caring for most became 24/7 and we know that this has taken its toll. It has been gratifying over the last twelve months to be able to reinstate all our services face-to-face and the staff have welcomed back all our old - and new - friends with open arms to Carer Cafes, Young Carer Clubs, social groups, training sessions, exercise classes, school holiday programmes and our ever-popular arts and culture programme.

We have also invested considerable time over the last 12 months in listening to your experiences at our Carers Forums, through focus groups and, indeed, at every contact. Your feedback is really critical to how our services develop and helps to ensure that the finite resources we do have are invested to best effect in terms of the support we can offer you. Please keep talking to us and we will work hard to fill any gaps you find in your circles of support, or will create the right relationships to try to address any gaps.

It just remains to say on behalf of the whole team at Carers Trust Hillingdon that we hope you are starting to feel that you have regained some control in your lives, that things are starting to feel more normal and that you are coping with the changes that the last couple of years has inevitably meant for you. Stay positive and keep in touch with your stories.

New services



The pandemic had a huge impact on everyone's lives and has affected many of us emotionally, physically, financially and psychologically. We know that your caring roles became even more challenging and complex almost overnight and not just in the short term - for a longer period than any us could have imagined at the start of the first lockdown. We know that those challenges remain for many of you with new issues emerging as the world continues to get back to 'normal' around you, with little recognition from government about just what the situation has meant for the country's unpaid carers - CarersUK estimates there are currently around 13.6 million carers nationally.

We have obviously not been in a position to respond to each and every personal situation that has been highlighted by carers through care-calls, face-to-face contact with staff, consultations and the many new carers registering with us that became carers either directly or indirectly as a result of the virus – an estimated 4 million nationally. However, we have listened and have, of necessity, focussed on developing new support where the need is greatest. In brief, new or extended services are:

- An extended Family Support service, with funding moved into supporting complex families, often with more than one caring situation under the same roof, who are facing a whole new range of social issues.
- Training in End of Life care to help carers with the necessary skills to provide
 effective end of life care for a loved one with a terminal diagnosis. The
 programme also offers help from a trained psychotherapeutic practitioner to
 help carers understand and manage grief and ensure they are supported by
 specialist services.
- Two new **Bereavement Support groups** to help carers to grieve and re-adjust to life after caring.
- A new Schools Outreach programme, providing emotional support directly to young carers in schools and helping them to catch up with missed education. Staff also work with pastoral care staff to help them to identify the young carers in their classrooms and to develop their own support.
- A Schools Information pack provided to all 70 Primary and 22 Secondary schools in the borough. The pack contains a range of fact sheets for teaching and pastoral care staff to improve their understanding of young carers' needs and challenges and a series of eye-catching posters for their Young Carers information boards.
- An extension of our Supported Transition programme for young adult carers in partnership with Harrow Carers. Many of our 16-25 year olds cross the borough border for college, work or recreation so we have joined forces with colleagues in Harrow to improve our collective support.
- A new programme of **Wellbeing workshops** called 'What about me?', offering carers a whole range of support and new skills to cope with their caring role.

Young Carers - our 2021-22 highlights

Despite the ongoing challenges of Covid-19 we were excited to be able to resume many of our young carer club sessions, trips, activities and workshops. We were so pleased to see everyone in person again and were amazed at just how much the young carers had grown!

Here are just some of our fantastic highlights from the year:

Back with a BANG!

We were successful in securing a grant from the ASDA Foundation to enable us to host two 'Welcome Back' parties in October 2021. We were delighted to resume our young carers Saturday club in Harlington and celebrated with a bouncy castle, party food and entertainment. In addition, we held a joint young adult carers Christmas Party with Harrow Carers where everyone enjoyed party food, a prize raffle, DJ, mocktails and a Christmasthemed quiz!

Gaining those grants

Our grant achievements continued throughout the year and we secured £8,955 of additional funding to enhance our activity and support offer. The grants were used to provide a residential weekend away for 14 young carers, seven wellbeing workshops for our young adult carers, plus laptops and interview clothes for three young adult carers seeking employment. We are pleased to report that all three were successful and are now working full time.

Proudly in print

Eight young carers had the amazing opportunity to create a landscape masterpiece to be featured in a published book. The book has been created by Baj Mathur, former Chair and Trustee of Hillingdon Carers (1996-2007), and contains a variety of his own landscape artworks. The pieces created by our young carers were beautiful and certainly showcased their artistic talents.

Success in Schools

In November 2021, we were successful in securing two-year funding for a dedicated Young Carers Schools Outreach Officer and have already made significant progress. We have worked with seven schools in the borough to improve their identification of, and support to young carers and as a result have received 51 new referrals to the service. We will be supporting these schools to achieve national accreditation through the Young Carers in Schools award.
